- ✓ Registration deadline is Friday, March 4, 2011. If payment is not received by deadline, alternate entries will be accepted.
- ✓ **Must have AADE dues current prior to shoot.**
- ✓ **All handguns are to be HOLSTERED when not in use.**
- ✓ **NO ALCOHOL! Must agree to and follow all safety rules.**
- ✓ **LIMITED TO THE 1ST 150 SHOOTERS TO SIGN UP and PAY!!**
- ✓ Lunch, drinks, and snacks included for the shooting.
- ✓ Ammunition is **NOT** provided and must be purchased at Anthony Arms (per their insurance).
- ✓ Center fire pistol or revolver. **No compensated/modified handguns.** No .22 Calibers pistols or smaller
- ✓ Preferred Calibers: .45, .357, .9mm, .38 spec.
- ✓ Scoring will be on an individual basis.
- ✓ Scorecards, to count, must be turned in immediately after the Shoot.
- ✓ **Hearing and eye protection required for all Shooters.**
- ✓ **Must be present at end of event to qualify for the drawing.**
- ✓ **Must have Holster & 3 clips/speed loaders prior to the 1st shoot.**
- ✓ Will need minimum of 45 rounds
