The President Speaks

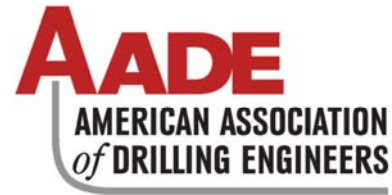

The 16th Annual Sporting Clays Tournament and Membership Drive on August 14 was full with 102 teams participating. Thanks to committee chairman Don Pearce, committee members, service company sponsors, and other volunteers, for their hard work and for a successful event which raised approx \$27,000 for our scholarship fund. Registration is underway for the 20th Annual Golf Tournament and Membership Drive on October 5 at Firewheel Golf Club. As of 8/31, 53 teams have registered. To share with you the significance of the AADE scholarship program, a list of AADE scholarships awarded for the 2008 – 2009 school year is included in this newsletter. A total of 104 scholarships were awarded at 27 universities by 8 AADE chapters, totaling \$219,000.

There were 51 in attendance at the July meeting in Fort Worth. Kelly Mcbeth, Austin based legislative strategist for natural resources, reviewed the effects the recently concluded Texas legislative session had on the oil and gas industry. There was no legislation passed that was bad for exploration. An estimated 20% of the bills filed would have had some effect on our industry. A bill was defeated that would have shifted some RRC jurisdiction to the county government level, but most likely will be introduced again next session. Nine bills regulating disposal wells did not pass, which would have been detrimental to shale gas development. One item of continued discussion is whether the RRC has jurisdiction over field rules for urban drilling.

The August meeting will be at the Las Colinas Country Club. The program will be presented by Don Sebastian with V&M USA (Vallourec, Mannesmann, Grant Prideco). Only two meetings are left in 2009. Please continue to support the DFW Chapter and the program presenters. As a final reminder, it would help us with meeting arrangements if you make an advance reservation by Friday September 11, per the instructions in the newsletter. The meeting cost \$30 with advance reservation and \$35 at the door.
